# **1. EXECUTIVE SUMMARY**

---

## **1.1 INTRODUCTION**

Bajkul Milani Mahavidyalaya is one of the premier government aided college of higher education in the district of Purba Medinipur, West Bengal, under the Vidyasagar University. It was founded on 3rd September of 1964 by Smt. Abha Maity, the then Honourable minister of state for industry in the Morarji Desai government from 1977 to 1979. Initially the college started its journey under the University of Calcutta and later it came under Vidyasagar University in 1985.

The college has a magnificent role in providing and promoting higher education to the students from rural area of the District of undivided Medinipur and also from neighbouring districts. The college has significant impact on the socio-cultural aspects of the surrounding areas of the college. The most significant feature of the college is that in-spite of large number of student strength and other constraints every action is carefully planned and so as to foster the composite cultural heritage of the district.

The college provides higher education each year to more than 3700 students on average in total 23 subjects in UG program and 5 subjects in PG program. Beside this one major course in Automobile Maintenance and an ITI course are offered by this college. Large number of students are offered placement in the last two courses through campusing each year.

The college conducts various extensive activities as a part of its community service plan through NSS units (Unit-I, II and III), NSS department, IQAC in collaboration with other organizations.

The college maintains a healthy and beautiful campus through continuously. The overall view of the college campus is attractive for students and other peoples. The college campus is ragging free.

The SSR cycle 3 has been prepared by the College IQAC/NAAC committee by gathering requisite information from the internal as well as external sources and consolidating the same in the format provided by NAAC. The major portion of the information has been consolidated in the seven criteria devised by the NAAC and are summarized as below

3. Majority of the students are from Bengali medium hence lack good command in English language
4. Lack of sufficient financial aid.
5. Development of infrastructural facilities to adopt with curriculum under National Education Policy 2020.

## **1.3 CRITERIA WISE SUMMARY**

### **Curricular Aspects**

College gives intensive efforts to provide quality education to students through effective curricular planning and deliver it through well-planned and documented process. Academic subcommittee of the college conducts its regular meetings with the departmental HODs/Coordinators for preparation of academic calendar, implementation of academic plans, completion of syllabus, to discuss about academic facilities and analysis of students result in internal and university examination. The college provides various Add on and certificate courses for betterment of the students.

Transacting the curriculum crosscutting issues relevant to professional ethics, Gender, Human values, Environment and Sustainability are introduced to the students through seminars, tree plantation programs, Yoga camp, social awareness camp etc. students maximum disciplines take part in project work, field work and internship. Departmental teachers take complete responsibility and help the students in completing their project/field work. Field works are conducted in the local areas, coastal belt of the district and also different parts of the India regarding geographical aspects, social and economic status of people, environments, industrial visit etc.

IQAC collects feedback on the academic performance and ambience of the institution from students, teachers, employees, alumni etc. and after comprehensive analysis of the report suggests necessary measures and plans to

overcome the problems issues from the report. The reports are made available on the college website.

College has future plans for flexibility in learners to greater extent, to promote more job oriented and value added courses in compatibility with the National Education Policy -2020.

### **Teaching-learning and Evaluation**

The most important thing is that the college has a permanent examination cell and an effective academic sub-committee for monitoring the teaching-learning and evaluation process of the college. Departmental teachers are highly active in completion of syllabus in due time.

Admission process is transparent, flexible, and completely in online mode. Government rules and regulations are maintained in admission to the seats reserved for SC/ST/OBC etc category students. Beside permanent full time teachers college have a large number of State Aided College teachers to maintain regular class loads. Student centric methods are adopted in the form of experiential learning, participative learning, class test, home task, assignment. To enhance learning experiences power point presentation using LCD projectors and other ICT tools are used by the teachers. There are facilities of smart class rooms. Teachers bear good academic qualifications with effective teaching capacity. Programme outcome and course outcome of all courses are displayed in the college website for awareness of the students.

### **Research, Innovations and Extension**

Teachers are involved in research activities, publish research papers in reputed journals, and write books and chapters in edited volumes. Teachers and students are involved in innovative activities and transfer knowledge through collaborative way with other institutes and organization. Various types of extension activities are conducted by the college in neighboring community for sensitizing students in social issues for their holistic development. Collaborative activities under MOUs are done with five institutes/organizations regarding student exchange, faculty exchange, internships and job oriented activities. College has good record of NSS and NCC activities like cleanliness programme, tree plantation programme, awareness camps, social survey, seminars promoting gender equity, women empowerment, AIDS awareness, thalassaemia screening camp in college campus and surrounding areas. NSS units has an adopted village namely Tethebari near Bajkul. College has received award from Mahatma Gandhi National Council of Rural Education, Department of Higher Education, Ministry of Education Government of India for its extensive activities.

### **Infrastructure and Learning Resources**

College is well equipped with adequate infrastructure and physical facilities viz., 45 class rooms, 24 well equipped laboratories. An indoor sports complex with sport equipments, modern gymnasium is available in the college. College has 10 class rooms with ICT facilities. Yoga camps are arranged in the indoor sport complex. Construction of an auditorium is under process. College has a central library with 35 thousands of books with regular accessibility for the students. Library has membership of e-journal, e-books, e-sodhsindhu, sodhganga (NLIST, NDL) and local and remote access through OPAC. Each department has computer facilities for use of students' use for their academic purpose. Internet facility (INFLIBNET) is available for office, principal's chamber, examination cell, central library, departments and students. Significant percentage of total expenditure is incurred in last five years for maintenance of infrastructural facilities.

## **Student Support and Progression**

College has well planned policy to aware students to avail scholarships from different government and non-government agencies. Total 12458 scholarships have been received by the students in last five years. College has received Kanyashree award for such achievement. Identification of students from financially back-ward back ground and to provide them with frees concession is an important activity of the college. Capacity building and skills enhancement initiatives by college are reflected in the activities like soft skills courses, spoken English course, computer course, Yoga course. It is documented that numbers of students from this college qualified JAM, GATE, GMAT, CAT, SET and NET are 12, 18, 1, 1, 17 and 43 respectively. Number of student progressed to higher education in the last five year is 411, and 150 students have secured placement in different sectors. Student participation in different sports and cultural competition is good. There is a registered Alumni Association of the college which contributes in holistic development of the institution.

## **Governance, Leadership and Management**

Institute has well planed future perspective in its administrative level to develop the infrastructural facilities to adopt the National Education Policy -2020. There are 29 sub-committees and 09 major committees except Governing Body, which takes part in policy formulation and implementation for holistic development of the college. Admission process, circulation of notice and orders, tendering process, financial transaction are done through online process. Employees are provided with service regarding loan benefit, leave benefit, PF-benefit. Performance Appraisal system is provided. Financial support is provided to the teachers for participation in workshops, seminars and in induction programmes. Number of FDP courses attended by teachers is 46 and by non-teaching staff is 87 in the last five years. Internal Academic Audit, Internal financial Audit and Green Audit up to date is completed.

IQAC conducts meetings with different subcommittees and plans strategies for quality assurance of teaching-learning methodologies and other academic facilities. IQAC collects feedbacks from different stake holders, analyzes it and takes measures for improvement. IQAC contributes in submission of college data in AISHE portal and also conducts collaborative initiatives with other institution through seminars, student and faculty exchange for quality development of the institution.

## **Institutional Values and Best Practices**

By conducting seminars, commemorative days, by involving the women employees in different sub committees (specially Anti-ragging cell and Grievance & Redressal cell) and involving the girl students in sports and cultural activities college tries to promote gender equity in the institutional level.

Green audit and energy audit for the last session have been conducted. As a part of green campus initiatives college has taken different action through waste management system (for biodegradable and non-degradable waste, chemical waste, glass waste), vermicompost system, tree plantation and cleanliness programmes through NSS activities, covered drainage system and by providing ecosystem for maintenance of biodiversity in the campus. College pond is used as rain water conservation system. There is a rain water harvesting system to restore underground water. A solar plant is installed as an initiative to use of alternative energy source.

Institution through its extensive activities has created an inclusive environment regarding connection with

society and culture, promotion of gender equity, tolerance and constitutional responsibility within the students, employees. Out many best practices institution imparts continuous effort on freeships for financially backward students and blood donation camp in collaboration with other social organization.

### **Institutional preparedness for NEP**

1. Multidisciplinary/interdisciplinary:	As per notification and order of the affiliating university, Vidyasagar University, as well as State Government of West Bengal National Education Policy already have been implemented in the first semester of UG programme from the session 2023-2024 in multidisciplinary mode in 24 four subjects in our college.
2. Academic bank of credits (ABC):	As per instruction of the Vidyasagar University college has notified to all the students to open ABC Id in proper portal. During admission to first semester in the session 2023-2024, ABC Id of all students were mandatory criteria for form fill up. We are in process to implement online courses through



	National schemes like SWAYAM, NPTEL, Coursera, etc, for our students and considering for credits earned against elective courses.
3. Skill development:	college, after comprehensive analysis in its administrative body has decided to open new skill development courses beside the existing courses to offer students academic flexibility. Courses like disaster management, surveying, remote sensing and GIS, hand-loom, beautician training, basic computer course and spoken English are in proposal.
4. Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course):	College has already created an inclusive environment for appropriate integration of Indian knowledge through celebration of Independence day, Republic day, International Mother Language day, Women day, National Youth day, etc. College conducts different cultural activities like Basant Utsav, Agomoni Utsav to promote Indian culture. College has plan to introduce courses to offer learning Indian Language in online mode.
5. Focus on Outcome based education (OBE):	To focus on out come based education college prepares POs and COs of each subjects. Community participation and service, environmental education, and value-based education are all part of an innovative curriculum that includes credit-based courses and projects. Lab experiments and mini projects with a focus on community health awareness & promotion are included in the curriculum. Professional Ethics & Human Values, Gender sensitization are value-based education courses that are introduced in Departmental programmes. Environmental Sciences is a course that looks at all areas of environmental sustainability.
6. Distance education/online education:	Due to Covid -19 pandemic, educational institutions in the country have increasingly involved in using the digital platforms for engaging classes, conducting conferences and meetings. Online education has broken the geographical barriers creating interaction of experts and students from far off places. Opening up of the economy including that of educational institutions has paved the way of adopting hybrid mode of education combining online and offline resources. This can be considered as the new normal, which is envisaged in New Education Policy as well. Due to the experience gained during lock-down period of Covid-19, access to online resources by

educators and students will not be a constraint any more.

##### 1.1.1

**The Institution ensures effective curriculum planning and delivery through a well-planned and documented process including Academic calendar and conduct of continuous internal Assessment**

**Response:**

(1) At the beginning of each academic session, the current prospectus is given to students in order to make them aware of the history and previous accomplishments of the institution. All the departments responsibly ensured that their respective students get a tentative idea of how the different texts and topics of the syllabus will be approached in the online classes. In this session upto January 2022 classes were conducted in blended mode i.e. through both online and offline mode. From February 2022 classes were held only through traditional offline mode. All the necessary information like teaching plans, time tables for online classes, other important notices like the schedule of tutorials were provided to students in due time. The orientation for the newly admitted students was conducted by each department through the online platform of Google Meet. Departmental meetings were conducted regarding syllabus distribution, completion of syllabus and conduction of internal and University examination. Internal assessment is conducted centrally. Attendance record of students is collected from the respective departments by the exam cell of the college. The institution also has active NCC and NSS students.

(2) Keeping in mind a well-planned system of curriculum implementation the academic calendar is prepared at the beginning of the academic session. Following the academic calendar of the affiliated university tentative dates of admission, commencement of classes, internal examinations and final examinations are incorporated in the academic calendar of the college. The college goes back to this calendar from time to time to notify the various dates of academic activities as already mentioned above. This academic calendar becomes a helping tool to the faculty members who prepare their respective teaching plans according to it. Heads of the different departments ensures the completion of the syllabus according to the teaching plan. Internal examinations and assignments are part of the continuous internal evaluation of students. Teachers give assignments to their students following the teaching plan of respective departments. The internal examinations are conducted according to the academic calendar of the college.

## 2.5 Evaluation Process and Reforms

### 2.5.1

**Mechanism of internal/ external assessment is transparent and the grievance redressal system is time- bound and efficient**

**Response:**

The college follows a transparent evaluation system and each and every department is strictly guided to do so. Some differences in the evaluation system may be perceived due to methodology specific variations. Students are strictly evaluated on the basis of what has been taught in class. Sometimes, to examine the analytical skills of students, ‘trick questions’ are given and students are always informed beforehand about the possibility of such questions in the class. The college also motivates its various departments to go through a continuous evaluation process, in place of the traditional examinations, and keep a track of the progress of the students.

Teachers of our college always provide a helping hand to assuage the various queries and anxieties of the students. Teachers make sure that all grievances of students are heard and mitigated through proper explanation and discussion. Many departmental teachers make it a point to discuss with students about the errors they commit in their internal evaluations so that they can rectify them properly.

The college always tries its level best to remain flawless in its execution of all official matters but to err is to human. In rare cases when unintentional human errors crop up the IQAC takes the onus to prevent

such unfortunate incidents. When any such inadvertent mistakes are reported the honorable TIC is immediately informed and he takes up the matter through proper channel with the affiliated university. He ensures that it is resolved within four weeks from the report of the same. Students having low attendance are warned beforehand so that they can obtain the requisite percentage of attendance required by the university.

### Maintenance of transparency:

The institute maintains transparency in evaluation by strictly following the guidelines and regulations set by the affiliating university viz. Vidyasagar University. As per the university, "The Choice Based Credit System (CBCS), an internationally acknowledged system, have following aims: (i) to make the course curriculum learner centric, (ii) to encourage inter-disciplinary learning without disturbing the domain centric knowledge, (iii) to promote mobility of the students and help in optimizing learning, (iv) to allow autonomy to the teachers to built in accountability, (v) continuous evaluation of students to help in optimizing learning, (vi) to introduce transparency in the evaluation systems, (vii) to improve employability of students." Thus, continuous evaluation of the student in a transparent manner is a stated objective of the university and this is followed accordingly by our institution as well.

## 3.4 Extension Activities

### 3.4.1

## 6.4 Financial Management and Resource Mobilization

### 6.4.1

**Institution has strategies for mobilization and optimal utilization of resources and funds from various sources (government/ nongovernment organizations) and it conducts financial audits regularly (internal and external)**

#### Response:

Resource mobilization is an essential part for the realisation of the vision and objectives of the institution. Resource mobilization includes not only financial matters but also the creation, expansion and identification of soft resources like technical and academic



skills, knowledge system and the utilization of machines and equipment. It is a way of uplifting various types of support for the institution. The raising of funds and financial support is achieved through the submission of proposals to interested donor agencies, the UGC and the affiliated university. Installation of photocopy machines also leads to generation of funds in the college.

The institution is run by mobilizing funds from grants obtained from the Govt. of West Bengal, Central Sector, interested stakeholders and fees received from the students. The salary component is borne entirely by the W.B. State Government. There are other sources for mobilization of funds for scholarships endowed to the students like the scholarship from various scholarships directly transferred to the students' accounts from the State Government / Private Sector like Sitaram Jindal Scholarship. The college has also received funds from M.P Lads, used for augmenting laboratory and campus development for the college. The state Government has also sanctioned some funds for development work like the Auditorium building in the college campus.

The Alumni Association regularly helps needy students to submit their examination fees. In 2021 and 2022 the Association donated. The college was allocated an amount of Rs. 2 crores from RUSA out of which Rs. 1.5 Crores is already received. Institution conducts internal and external (Govt. provided Auditors) financial audits regularly. At the initial stage, the Head of the Department or any other teacher from the department certifies that the material has actually been delivered or the service has actually been provided. For office purchases this certification is done by a responsible office staff or a member of the Finance Committee. This is again scrutinized by the Accountant, Bursar and the Principal for clarity, authenticity, transparency and financial accuracy. Income/Expenditure is closely monitored by the Bursar, the Principal and the Accountant properly. Quotations are called for and prices are compared. For the grants received from the UGC, West Bengal Government or other sources, utilization certificates are prepared according to the allowed expenditure under various heads. The Utilisation Grant Certificates are duly submitted to the concerned agency. The external audit takes place annually after the completion of every financial year. The Chartered Accountant, who works as an auditor on the recommendation of the Higher Education Department, Government of West Bengal. The college has no say in appointing the auditor. The bills and vouchers of the revenue expenditure are checked. The vouchers and proper record with the concerned Department of the capital expenditure is also checked and verified. The Utilisation Grant Certificates are also audited by the external auditor. Statutory external audit and assessment of Income- Expenditure and Receipt-Payment is also done by the external auditor. The audit objections/compliance, if any, is handled by the Accounts Department.

IQAC takes different strategies for internal quality assurance in various aspects of the academic institution. Total 24 subjects are taught in the institution including UG and PG courses. More than three thousands and seven hundred students read in the college. The students come from rural or village areas. A significant part of the students are from poor financial background. Some students are first learner of their family. However, the college gets a large numbers of meritorious students.

But our college has 38 full time teacher posts, 98 State Aided College Teachers and 44 non-teaching employees. To maintain such a large numbers of student strength in regular basis, to provide a good teaching-learning environment, to provide a good administration, for proper documentation of all the information IQAC in collaboration with College administration adopts various policies and performs various activities in institutional level. Most significant activities are,

- 1.Meeting with different sub-committees to know their observation about different academic and administrative problems.
- 2.Meeting with college administrative office staffs to know about their requirements in smooth running of the official work
- 3.Proper documentation of students data ( application, admission, result and student progression, placement etc)
